



## Proposed fees for land title related products and services from 1 July 2013

Land and Property Information (LPI) intends to increase fees for land title related products and services from 1 July 2013. Increases will be in line with New South Wales Treasury forecast.

### What fees will change?

The following table lists current and proposed fees for an indicative range of land title related products and services.

#### **When will the new fees take effect?**

The intention is that the new fees will apply from 1 July 2013. LPI expects that regulations relating to the new fees will be published in June 2013 on the NSW legislation website [www.legislation.nsw.gov.au](http://www.legislation.nsw.gov.au).

Current fees will continue to apply until 30 June 2013. Lodgments made before 1 July 2013 but not completed until after that date will be charged at current 2012-13 rates.
