Proposed Land Title Lodgment, Examination and Related Fees, including Water Access Licence Register Fees

The Department of Lands is officially registered in the Australian Business Register and also registered for GST. Its ABN is 21 804 973 362

Land Property Information Division (LPI) plans to introduce a new schedule of fees for land title related products and services from 1 July 2005.

Current lodgment, examination and related fees for 2004-05 are listed on the Lands website at www.lands.nsw.gov.au/FormsAndFees/default.htm.

What fees will change?

Fees will generally increase in line with movements in the Consumer Price Index. A table detailing proposed fees for the main titling related products and services is attached. Key land title fee increases include:

Dealing lodgment \$77,25
Plan lodgment \$823.00
Lots in plans \$82.30

Document copies \$10.30 (over the counter)

On-line title searches \$8.25 (via http://lpi-online.lpi.nsw.gov.au)

Other proposed changes include:

- an increase in fees relating to the registration of crop and wool liens, stock mortgages, bills of sale, writs, orders and resumptions to bring them into line with fees for other documents registered in the General Register of Deeds such as conveyances and powers of attorney. The fee for all documents registered in the General Register of Deeds will be \$73.25;
- introduction of a postage fee for documents where lodging parties request delivery by mail to a street address (these documents are now delivered by registered mail as a security measure);
- provisions for the lodgment of applications to record appurtenant easements created by a deed in the Register, and also for the cancellation of extinguished easements; and



• separate fees for applications to bring land under the Real Property Act pursuant to section 14 and section 31A to account for the fact that applications under section 31A are generally less complex than those under section 14.

What impact do the fee changes have on Water Access Licence (WAL) dealings and searches?

By agreement with the Department of Infrastructure Planning and Natural Resources (DIPNR), the fee for WAL searches will be the same as the fees applicable for equivalent Torrens title searches. Fees for lodgment of WAL dealings are not equivalent to lodgment fees applicable for dealings lodged under the *Real Property Act 1900*. This is because a Torrens Assurance Fund levy of \$4.00 is included in the fee for each Real Property Act dealing. As indefeasibility of title is not yet offered for water access licences, no levy is applied to WAL dealings. WAL fee increases are summarised below:

•	WAL dealing lodgment (note exception below)	\$73.25
•	Application for replacement WAL Certificate	\$146.50
•	WAL searches (Over the counter delivery)	\$10.30
•	WAL searches (via http://lpi-online.lpi.nsw.gov.au)	\$8.25
•	WAL owner name search (Over the counter delivery)	\$2.10

Please note that the above fees relate only to transactions on the WAL Register. Licensing and other fees are applied by DIPNR.

When will the new fees take effect?

The new fees are expected to apply from 1 July 2005. Regulations relating to the new fees are likely to be gazetted in June 2005.

Fees as at 1 July 2004 will continue to be applied to services eg dealings, plans and search requisitions lodged before 1 July 2005 but not finalised until after 1 July 2005. New 2005-06 copy tickets will be available for purchase from the LPI cashiers desk on the Ground Floor at LPI's Queens Square Sydney office from Monday 20 June 2005. Unused old tickets may be exchanged for new tickets at the cashiers' desk from 1 July 2005.

Payment of fees by cheque

Customers are reminded that a charge of \$44.00 (including GST) is payable by the lodging party in any instance where a cheque made out to Lands is dishonoured on presentation to the relevant bank.

Where can I get more information?

LPI will issue another circular to confirm details of the new fees as soon as the regulations have been gazetted.
