### Proposed fees for land title related product and services from 1 July 2008

The Department of Lands is officially registered in the Australian Business Register and also registered for GST. Its ABN is 21 804 973 362

Land Property Information Division (LPI) intends to increase fees for some land title related products and services from 1 July 2008.

#### When will the new fees take effect?

The new fees will apply from 1 July 2008. Regulations relating to the new fees will be gazetted by June 2008.

Fees from 1 July 2007 will continue to apply until 30 June 2008, and lodgments made before 1 July 2008 but not completed until after that date will be charged at 1 July 2007 rates.

#### Why are the new fees being announced now?

It is our policy to advise customers of planned fee increases well in advance of the implementation date as we want to give everyone time to prepare for their introduction.
